Grant Eligibility and Guidelines

Grantee Eligibility

- Must be classified as a 501(c)(3) public charity under the Internal Revenue Code (this does not apply to government agencies or public-school districts)
- Must file IRS Form 990 (or 990-EZ or 990-N) annually
- Must register with the **PA Bureau of Charitable Organizations** (BCO-10)
- Must provide services directly to Centre County
- Funded programs must comply with Centre Foundation's <u>Nondiscrimination</u> <u>Policy</u>
- Must be in good standing with previous Centre Foundation grants

Grantee Eligibility

- Things we **do not** fund:
 - Lobbying or political activities
 - Sectarian religious activities
 - Reimbursement for expenses incurred before grant is awarded
 - Requests from individuals

Centre Gives

- Centre County's 36-hour online giving event
- Last year, \$2.3 million was raised for 205 nonprofits
- From 8 am on May 8 until 8 pm on May 9
- Verified 501(c)(3) nonprofit organizations that serve Centre County
- Register at <u>www.CentreGives.org</u> from February 1 until March 15

Creative Sector Flex Fund (CSFF)

- Application opens June 4 and closes July 25
- Deadline to receive feedback: July 11
- Program of the Pennsylvania Council of the Arts through the Pennsylvania Partners in the Arts regional partnership
- Supports **arts organizations and programs** in Centre, Clearfield, Clinton, and Huntingdon counties
- Provides \$5,000 flexible grants for administrative, programmatic, or project-related expenses



CSFF Eligibility

Applicants must:

- Be a nonprofit, tax-exempt corporation, or a unit of local government (counties, cities, boroughs, townships, and municipal authorities); Unincorporated groups may apply through a 501(c)(3) fiscal sponsor
- Be registered with the Pennsylvania Bureau of Corporations, except for local governments and fiscal sponsors
- Have an average annual revenue between \$10,000 \$200,000
- Have a history of at least two years of consistent arts programming



Giving Circle

- Centre Foundation's membership-based grantmaking group
- Members pool their resources to award grants to Centre County nonprofits
- Since 2006, the Giving Circle has awarded over **\$240,000** in grants

Giving Circle Grants

- Application opens July 9 and closes August 22
- Deadline to receive feedback: August 8
- Open to 501(c)(3) nonprofit organizations for dynamic programs & projects serving Centre County
- Three finalists present live pitches to the Giving Circle membership
- Provides one \$10,000+ grant and two grants for runners-up
- Finalists must skip one year before reapplying

Field-of-Interest (FOI) Endowment Funds

- Centre Foundation manages 17 field-of-interest funds
- Each FOI fund supports a particular cause or geographic area, spanning health and social services, education, youth development, animal welfare, the arts, and more
- **\$147,048** was awarded to 40 nonprofits in 2023

• Ben Franklin Fund for Projects or Programs in Centre, Clearfield, Huntingdon, and Mifflin counties

Field-of-Interest Grants

- Application opens August 6 and closes September 26
- Deadline to receive feedback: September 12
- Open to 501(c)(3) nonprofit organizations, government agencies, municipalities and public-school districts. Unincorporated groups may apply through a 501(c)(3) fiscal sponsor.
- Applicants may submit more than one application for separate programs or projects
- Some FOI funds overlap; applicants are encouraged to request funding from multiple (relevant) funds



Centre PACT

- Centre Foundation's youth advisory council for Centre County high school students
- Participants discuss issues facing their peers, learn about potential solutions that nonprofits offer, fundraise, and fund local programs
- Since 2016, members of Centre PACT raised and granted over \$45,000 to 24 local nonprofits

Centre PACT Grants

- Application opens December 3, 2024 and closes January 16, 2025
- Deadline to receive feedback: January 11
- Open to 501(c)(3) nonprofit organizations for projects and programs that serve young people (Pre-K–12) in Centre County
- Grant awards typically range from \$500 \$3,000
- Priorities shift annually but typically include mental health, school safety, and equitable educational opportunities

Creative Entrepreneur Accelerator Program

Creative Entrepreneur Accelerator Program

- Rolling application deadline
- Partnership between the Pennsylvania Council on the Arts, PPA Partners, and SBDCs serving creative entrepreneurs in Centre, Clinton, Clearfield, and Huntingdon counties
- Pairs creative entrepreneurs with access to free small business consulting services and \$2,000 grants to form or grow your creative small business

Eligibility Criteria

Applicants must:

- Be at least 18 years of age and a current resident of Pennsylvania for at least one year
- Be an entrepreneur intending to form or currently operating a small creative business in Pennsylvania in an eligible industry including Marketing, Architecture, Visual Arts & Crafts, Design, Film & Media, Digital Games, Music & Entertainment, or Publishing

Note: Creative entrepreneur's business must have gross revenue less than \$200,000

Application Process

- Applicant requests a free consultation with an approved Referral Coordinator
 - Clarion SBDC, Penn State SBDC, St. Francis SBDC, PA Wilds Center, or Startup Alleghenies
- Referral Coordinator reviews applicant's business plan and refers applicant to Centre Foundation
- Applicant submits an **online grant application** through Centre Foundation
- Centre Foundation reviews application for eligibility and issues grants awards




Scholarships

- Centre Foundation administers more than 150 scholarships and awards for school districts across Centre County and beyond
- Over **\$390,000** awarded last year
- Opportunities for high school seniors, adult learners, first responders, and more

Endowment Funds

- Serving the organizations and individuals who are passionate about the future of Centre County
- Endowments provide consistent, long-term funding for your organization
- Centre Foundation handles administration of endowments, including investment oversight, donation processing, and donor acknowledgement, etc.
- Any 501(c)(3) public charity is eligible to open an endowment with Centre Foundation
